The Catholic Family History Society exists to encourage Catholics and those who have Catholic ancestry (however distant) to research their family history. It publishes a journal three times a year, and there is a local group which arranges meetings in NW England. The current subscription rate is £15.00 per year, with an extra £2.00 for each additional member **at the same address** and sharing one copy of Catholic Ancestor. The subscription for overseas members is £20.00 per year with a similar arrangement of £2.00 for an additional member. Payment can be made in Sterling, International Money Order or simply online at GENfair. The subscription year ends on 31st December. All new members joining the Society up to 30th September will have received all issues of Catholic Ancestor for the year, so their subscription will be due **on or before** 1st January in the following year. Members who join on or after 1st October in any year will receive only the December issue, but their membership will be extended to the end of the following year.
